## **DECLARATION OF CONSENT**

## **SUBSIDIZED TICKETS**

## **REFUND AND CANCELLATION POLICY**

All purchases of tickets for conferences and events (including hotel rooms if applicable) are non-refundable in their entirety, after the 7 day cooling off period. Any Refund Processed is subject to €10 or transaction fee. Your ticket remains the property of Institute of Contemporary Science and is a personal revocable license, which may be withdrawn, and admission refused at any time upon a refund of the printed registration price.

In the unlikely event of cancellation of a conference or event, the liability of Institute of Contemporary Science is limited to the share of paid registration fees that remains after credit card and payment processing fees have been incurred and deducted.
